



# UNIVERSITAS HASANUDDIN AND UNIVERSITI TEKNOLOGI MALAYSIA AGREED ON DEVELOPMENT COLLABORATION


Universitas Hasanuddin and Universiti Teknologi Malaysia (UTM) agreed on collaboration for the development of the threefold mission of higher education which is called Tri Darma Perguruan Tinggi. The agreement was stated in the Memorandum of Understanding (MoU) signed by the Rector of Unhas (Prof. Dr. Dwia Aries Tina Pulubuhu, MA) and the Vice Chancellor UTM (Prof. Datuk Ts. Dr. Ahmad Fauzi bin Ismail). Starting the activity, Prof. Datuk Ts. Ahmad Fauzi gave a general overview of UTM in his speech. He explained that UTM is the biggest engineering university in Malaysia which manages 11 faculties.

The Collaboration with Unhas is expected to increase quality as an educational institution and strengthen the Indonesia and Malaysia partnership. "This cooperation, hopefully, can be implemented well. In the near future, we can broadly expand our collaboration and of course improve the good relationship between UTM and Unhas, "explained Prof. Fauzi.

On the same occasion, Prof. Dr. Dwia Aries Tina Pulubuhu, MA., welcomed both parties' collaboration. As an autonomous institution (PTN-BH), Prof. Dwia conveyed that Unhas continues to make strategic efforts in producing superior human resources, one of which is by looking at international partnerships opportunities. "Unhas wants to engage more in society actively, so we continue to maximize our innovation and prioritize humanitarian action in accordance with the slogan of Humaniversity.

Therefore, we hope this collaboration can enhance the quality of Unhas and UTM, "explained Prof. Dwia. The agreement with a validity period of five years contains several important points. One of them includes academic expansion through student exchanges and collaborative research, innovation, and publication. In the future, this collaboration can be developed in other fields based on the agreement and needs of the two parties.

## THE FACULTY OF LAW OF UNIVERSITAS HASANUDDIN DISCUSSED CHALLENGES OF MULTILATERAL COOPERATION WITH THREE INDONESIAN AMBASSADORS



The Faculty of Law (FH) Hasanuddin University (Unhas) held a webinar entitled "Ambassador Session" under the theme "Challenges of Multilateral Cooperation During the Covid-19 Pandemic". The activity as part of the 69th Anniversary of the Faculty of Law Unhas was conducted, starting at 1:00 p.m., virtually through the zoom meeting application, Tuesday (16/03).

H.E Hamid Awaluddin (Indonesian Ambassador to the Russian Federation and Belarus for the 2008-2011 Period), H.E. Dr. (Hc) Lutfi Rauf, MA (Indonesian Ambassador to Egypt) and H.E. Tri Tharyat, S.H., LL.M (Indonesian Ambassador to Kuwait) attended the meeting as speakers. The activity was officially opened by the Deputy Dean for Planning, Finance and Resources, Dr. Syamsuddin Muchtar, SH., MH. In his introduction, he explained that the theme of this webinar was chosen under the consideration that multilateral cooperation has an important role for the common interest.

Syamsuddin added that the new problem of the Covid-19 pandemic spreading in various countries has had an impact on all aspects of life.

Through this webinar, it is hoped that it can become a forum to discuss the challenges of Indonesia's diplomacy during a pandemic, and diplomatic steps in dealing with pandemic issues while maintaining good relations with other countries.



H.E. Dr. (Hc) Lutfi Rauf, MA, as the Indonesian Ambassador to Egypt explained his views on "Challenges of Indonesian Diplomacy in Overcoming the Covid-19 Pandemic". He said that Covid-19 has had a major impact on various global life orders. Since the pandemic began, the country has experienced a global economic recession, down 4.4% in 2020 and the worst since the economic depression of the 1930s (IMF).

Lutfi added that the pandemic has a dominant effect on social, economic and financial aspects. Therefore, in dealing with the impact of the pandemic, multilateral cooperation is needed in accordance with the WHO platform. In Egypt, 35 Indonesian citizens have recovered and 8 people are still being treated because of Covid-19.

"As an effort to mitigate the spread of Covid-19 among Egyptian citizens, the Indonesian Embassy in Cairo strengthens the service to respond to Covid-19 increases Indonesian citizens' understanding of the ways and importance of health protocols," Lutfi explained. Another speaker, H.E Hamid Awaluddin, said that Covid-19 is in a complex position of interdependence which does not only speak in the context of strength, but rather how to encourage and seek human safety and solve problems.

## UNHAS HELD A WEBINAR SERIES DISCUSSING THE IMPACTS OF COVID-19 PANDEMIC TO WOMEN



UNHAS through the Center of Excellence for Interdisciplinary and Sustainability Science (CEISS) in collaboration with the Partnership for Australia-Indonesia Research (PAIR) held a webinar series on the heading issue "Covid-19: Crisis with Women's Face". It took place from 15.30 to 17.30 WITA virtually by way of zoom meeting application, Monday (29/03).

This webinar was officially opened by the Dean of the Unhas Postgraduate School, Prof. Jamaluddin Jompa, Ph.D. In his remarks, he said that gender issues are part of an interdisciplinary way of looking at problems and preparing solutions in a comprehensive manner.

Resource persons presented were Rosalia Sciortino Sumaryono (Associate Professor at the Institute for Population and Social Research, Mahidol University, Thailand), Ema Husain (activist for women's rights) and Sudirman Nasir (Chair of CEISS and Lecturer at FKM Unhas).

Rosalia Sciortino as the first speaker delivered material on an issue of "Gender Dimensions of the Covid-19 Pandemic in Southeast Asia". According to her, Covid-19 is not only related to the aspect of medical or epidemic problem, but also it shows a system failure at the environmental, economic and gender equality levels. However, since the pandemic occurs, the inequality has become more exacerbated. One of the impacts is that a number of women lose their jobs. Rosalia added that in facing gender inequality, special protection and an adequate social change are highly required for women, especially in the informal sector, as well as a government program that is able to provide assistance to women and children.

Another perspective was also shared by Ema Husain regarding "The Face of Women in the Covid-19 Period" arguing that women have already encountered numerous problems, and it becomes even worse during the pandemic. In Indonesia, when talking about women, she always uses the Principle of Human Rights & Women's Rights (HAP). Pursuant to her perspective, the Covid-19 handling scheme has not yet been responsive to women, children, disabilities and the elderly. Since the pandemic, the stay-at-home policy has exposed women to difficult situations and restricted their movement. Pandemics do not only threaten health, but there are also problems that affect women, both directly and indirectly.

## UNHAS FACULTY OF PHARMACY OPTIMIZES INTERNATIONALIZATION THROUGH COLLABORATIVE RESEARCH AND GUEST LECTURES

The Faculty of Pharmacy of Universitas Hasanuddin has a duty and role in encouraging the improvement of the institution's reputation both on a national and international scale. This form of tribute includes optimization of partnerships, research collaboration, and guest lectures as well as webinars with international sources.

Prof. Subehan, M. Pharm.Sc., Ph.D., Apt, as the Dean of the Faculty of Pharmacy of Unhas said that the Faculty of Pharmacy continues to increase its role locally, nationally, regionally and internationally.

After successfully gaining ASIIN's international recognition, the Faculty of Pharmacy took steps to expand the reach of partnerships to various international institutions.

Prof. Subehan explained that through a collaborative scheme, the Faculty of Pharmacy will try to partner with several overseas institutions, such as Kanazawa University, James Cook University, The University of Queensland, King Abdul Aziz University and The University of Cambridge. This collaboration began with individual research collaboration with lecturers from the five universities and then continued into institutional collaboration.

The activities carried out were a number of guest lectures and webinars that presented speakers from the partner universities.

Not only holding lectures by foreign lecturers, the Faculty of Pharmacy of Unhas will also present a Student for Student (Stu4Stu) Conference, in collaboration with the College of Public Health, Medical, and Veterinary Sciences (CPHMVS) James Cook University, Australia. In this activity, students and young researchers from both universities will present various research results.


The Vice Dean for Student and Alumni Affairs, Faculty of Nursing Unhas, Syahrul Said, S.Kep., NS., M.Kes., Ph.D., explained (Tuesday, 30/3) that the Kanazawa University Exchange is an annual program for students from several countries.

There are two learning periods in this exchange program: a one-year program and a six-month program. The participation of students from the Faculty of Nursing is an effort to encourage and maximize the achievements of Unhas in the World Class University (WCU). On a separate occasion, Dhiya Khalilah Taufan explained that her participation in this program was part of scientific development that she wants to improve. She has acquired additional learning opportunities and skills relevant to her academic interests as a result of this opportunity.

She has also mentioned that her presentation skills significantly have been developed. This program was initially scheduled in March 2020 at Kanazawa University.

However, it must be postponed and conducted online due to the Covid-19 pandemic. Dhiya received a scholarship to participate in this event, which was fully funded by the organizer of this program.

### UNHAS INVOLVES IN ASEAN AND EUROPEAN INTERNATIONAL PROJECTS



UNHAS, one of 29 well-known universities in ASEAN and Europe, involved in the CALOHEA project (Comparing Achievements of Learning Outcomes in Higher Education in ASEAN).

There are two study programs in Unhas involved, Medicine and Civil Engineering Study Program which are the first two study programs certified by AUN-QA in 2016. Meanwhile, all funding comes from the European Commission. Through this platform, the international reputation on Unhas will increase so that it is easier to establish collaboration, both in the field of education such as credit-earning, joint or double degree, and increasing the number of Unhas international students. A total of 29 well-known universities from 13 countries, 5 from Europe and 8 from ASEAN, involved in this project. Later, Unhas' experience in this project, mainly for the two study programs (Medicine and Civil Engineering), can be adopted by other study programs to improve quality and boost international reputation.

During the pandemic, all parties will discuss this project in more depth via video conference. The universities involved in this project had an initial meeting on Tuesday (09/03) with an agenda for further discussion about CALOHEA and what tasks needed to be carried out by the universities involved.

## THE CEREMEONY OF JAPANESE GOVERNMENT SERVICE STAR AWARD FOR PROF. HUSNI TANRA



The Japanese government awarded a Service Star in the category of "The Order of the Rising Sun, Gold Rays With Neck Ribbon" to Prof. dr. A. Husni Tanra, Ph.D., Sp.An., a professor of the Universitas Hasanuddin of Faculty of Medicine.

The Service Star of "The Order of the Rising Sun, Gold Rays with Neck Ribbon" has been awarded to both Japanese & international party with outstanding contribution to Japan in their respective fields since Meiji era.

The Head of the Japanese Consular Office in Makassar, Miyakawa Katsutoshi, explained that the active contribution of Prof. Husni Tanra in increasing academy exchanges and friendly relations between Japan and Indonesia leads him to achieve this award.

Prof. Husni's contribution in improving friendly relations between Japan and Indonesia was also seen when he was elected as the Chairman of the Association of Japanese Alumni from South Sulawesi (PERSADA SULSEL) in 1987-2000.

He is actively engaged in introducing Japanese culture on various occasions and providing opportunities for members to improve their Japanese language skills. Prof. Husni Tanra also maintains a relationship with the Association of Japanese Citizens (Nihonjinkai) South Sulawesi and often advises Japanese people studying or serving in Indonesia. During his tenure, PERSADA members, which initially numbered around a dozen people, increased to more than 100 people.

Prof. Husni Tanra had the opportunity to represent Unhas at the International University Exchange Seminar held by the Association of International Education Japan (AIEJ) in 1974. He met the Chancellor of Hiroshima University, lijima Souichi, who was also a Doctor of Medicine. Souchi invited Husni Tanra as the only medical student who attended the seminar to continue his education at Hiroshima University.

"This is the starting point of Mr. Husni Tanra's relationship with Japan. With the various contributions he made, the Japanese government decided to award him a Service Star. Formally, this service star was awarded on November 3, 2020, the season of autumn in Japan," explained Miyakawa.

The accomplishment achieved by Prof. Husni were also appreciated by the Rector of Unhas, Prof. Dr. Dwia Aries Tina Pulubuhu, MA. She explained that this achievement was also a matter of pride for Unhas, which not all people could accept the award. Prof. Husni deserved to receive this award for his various active accomplishment.


The Faculty of Dentistry of Hasanuddin University held an international conference entitled The 5th International Conference on Biophysical Technology in Dentistry (ICoBTD) under the theme "Optimizing Plants and Approaches in Pandemic Dental Treatment".

In collaboration with the Faculty of Dentistry, Airlangga University, this conference was conducted, starting at 09.00 a.m., virtually through the zoom meeting application, Thursday (25/03). As stated by the Dean of the faculty of Dentistry, Hasanuddin University, drg. Muhammad Ruslin, M.Kes., Ph.D., SpBM(K), this activity was conducted with an aim to provide a space for enhancing knowledge, expanding networks and experiences, as well as discussing the role and the development of dentistry.

This conference presented 14 speakers from 8 countries, they were: Prof. Dr. Chandan Upadhaya, MDS., (Kathmandu University, Nepal), Prof. Mark Tennant, BDSc., Ph.D., W.Aust., AFCHSE., FICD (University of Western, Australia), Prof. Lih-Jyh Fuh., DDS., Ph.D., F.I.C.D (China Medical University, Taiwan), Prof. Hong-Keun Hyun, DDS., MSD., Ph.D (Seoul National University, South Korea), Dr. Priyanka Sakhavalkar, BDS., MDS., M.Sc., (Alder Hey Children Hospital, Liverpool, United Kingdom), Dr. Ajay Bhoosreddy (University of Health Science, India) and Prof. Junichi Asaumi, DDS., MDsc (Okayama University, Japan)

After the opening, it was continued with the material presentation from the speakers which was divided into several sessions. One of the presentation was carried out by Prof. Dr. Chandan Upadhaya, MDS., (Department of Oral and Maxillofacial Surgery Director, Kathmandu University School of Medical Sciences, Nepal) who explained about "Routine Oral and Maxillofacial Surgery and Its Complications for General Dental Practitioner - An Overview".

He described about the oral and maxillofacial surgery process and the complications that may occur. Prof. Chandan also explained about the scope of work of oral and maxillofacial surgeons which consists of cancer surgical treatment, tumor removal and reconstruction. It was also discussed about micro-vascular free tissue transfer, surgery for craniofacial facial defects and correction of congenital facial deformities, dental surgeries including implants, jaw, temporomandibular joints, salivary glands, and surgery for facial-aesthetic improvement.
